Rebate Terms and Instructions:

Promotion and Rebate only valid on installed systems purchased from your distributor by an eligible Mitsubishi Electric Diamond Contractor or Ductless Pro.

System must be purchased by homeowner in residential, owner-occupied properties from Diamond Contractor or Ductless Pro between April 4, 2022 – June 3, 2022 and installed by June 24, 2022. Systems must be registered to qualify for co-op funding.

Rebate form must be submitted by Diamond Contractor or Ductless Pro to distributor no later than June 30, 2022.

Rebate credits will be issued by METUS to distributor in first week of August 2022.

Distributor Credits are due to contractors by August 29, 2022.

The Diamond Contractor or Ductless Pro must submit this completed Rebate Claim Form, together with the following required documents:

1.) A copy of the signed contract between the Diamond Contractor or Ductless Pro and the homeowner for the purchase and installation of the qualified equipment, detailing the instant rebate deduction given at time of sale.

2.) A copy of your distributor invoice to the Diamond Contractor or Ductless Pro. detailing model(s) and serial number(s). Quotes and acknowledgments do not qualify.

Extension Requests to address inventory backorders will be granted at METUS discretion and must be submitted along with the Rebate Claim Form and matching documentation prior to the same June 30, 2022 deadline.

Extension requests must accompany the Rebate Claim Form, along with copy of contract dated between April 4 – June 3, 2022 and must include a distributor order acknowledgement indicating backorder to assure that incoming product is allocated to this job.
